On completion of the building construction and after installation of the Fire Protection arrangement, the applicant shall fill the Check list-Cum Application again and also prepare a fire plan drawing and submit following the due procedure. On receiving the plan & the Checklist cum Application duly filled, the authorized and competent Officials of this department will inspect & verify the Fire Protection arrangements made as per the filled up Checklist to consider issuance of a Non-Objection Certificate (Completion) from this department for compliance of the proposed fire protection requirements.

This clearance is limited to the Fire Protection arrangements for the proposed Building. All other matters including eligibility of the land and plot for this project, environmental feasibility, survey details, etc should be not verified and approved by the concerned competent authority. This No Objection Certificate is issued for facilitating the construction of the proposed Building. The validity of this certificate will be for 5 years from the date of issue. Renewal will be subject to the conditions of building permit issued by the local authority.
